- 2. Promotion of education including special education, and employment oriented vocational skills and projects to enhance especially among women, elderly and the differently abled;
- Promotion of gender equality, empowerment to women, setting up of homes and hostels for women and orphans; setting up of old age homes, day care centers and such other facilities for senior citizens and measures for reducing inequalities faced by socially and economically backward groups;
- 4. Promotion of environmental sustainability, ecological balance, protection of flora and fauna, animal welfare, agro forestry, conservation of natural resources and maintaining quality of soil, air and water.
- 5. Training to promote rural sports and the nationally recognized sports;

- 6. Contributions or funds provided to technology incubators located within academic institutions which are approved by the Central Government;
- 7. Rural development projects including water shed building, good agricultural practices, assistance by supply of seeds and in marketing of the produce and crop productivity improvement, Animal husbandry etc.;
- 8. Contribution to the Prime Minister's National Relief Fund or any other fund set up by the Central Government or the State Government for socio-economic development and relief and welfare of the Scheduled Castes, the Scheduled Tribes, other backward classes, minorities and women;
- 9. The CSR projects or programs shall be monitored from time to time.
- 10. The surplus arising out of the CSR projects or programs or activities shall not form part of the business profit of a company.
